

**NATURE VALLEY BIN IT FOR A CHANCE TO WIN IT SWEEPSTAKES**  
**OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.**

The Nature Valley Bin It For A Chance To Win It Sweepstakes ("Sweepstakes") is sponsored by General Mills Marketing, Inc. ("Sponsor"), 1 General Mills Blvd., Minneapolis, MN 55426 and is administered by Prize Logic, LLC ("Administrator"), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

1. **SWEEPSTAKES PERIOD:** The Sweepstakes begins at 12:00 PM Eastern Time ("ET") on March 1, 2021 and ends at 11:59:59 PM ET on April 30, 2021 ("Sweepstakes Period"). The Administrator's computer is the Sweepstakes official clock.
2. **ELIGIBILITY:** This Sweepstakes is open only to individuals who are legal residents and physically located in one (1) of the fifty (50) United States (including the District of Columbia) and who are at least eighteen (18) years old at the date and time of entry. Any minor, as defined by his/her state of residence (which is eighteen [18] in most states but is nineteen [19] in Alabama and Nebraska and twenty-one [21] in Mississippi) ("Minor"), must have permission from his/her parent or legal guardian before entering the Sweepstakes. Employees, directors, officers, and agents of Sponsor, Administrator, and each of their respective parent companies, divisions, affiliates, subsidiaries, advertising and promotional agencies and suppliers involved in the Sweepstakes (collectively, "Sweepstakes Entities") and each of their immediate family members (e.g., spouse, parent, grandparent, child, sibling, grandchild and their respective spouses and the "steps" of each, all lineal descendants, including those by adoption, regardless of where they reside) and persons residing in the same household as such individuals (whether legally related or not) are not eligible to enter or win. All federal, state, and local laws apply. Void where prohibited by law.

Participation constitutes entrant's full and unconditional agreement to these "Official Rules" and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes.

3. **HOW TO ENTER THE SWEEPSTAKES:** During the Sweepstakes Period, an eligible entrant must visit <https://naturevalleywrappersweepstakes.com> ("Website") and submit his/her valid e-mail address. The entrant must then complete and submit the registration form, including, but not limited to: his/her first and complete last name (no initials), complete mailing address (P.O. Boxes are not permitted), date of birth, phone number, and agreement to these Official Rules. Upon completion and submission of the registration form, the entrant will receive one (1) entry into the Sweepstakes.

**NOTE:** An eligible entrant may receive a link to the Website using a web-enabled mobile device and scanning the QR Code printed on marketing materials. Once the QR Code is scanned, the entrant will automatically receive a link to the Website on their mobile device. The entrant may then log on the Website in his/her browser and follow the entry steps set forth in this Section 3 to enter. An entrant

is not required to scan a QR Code to participate and may go directly to the Website to enter. Note that an entrant cannot receive an entry into the Sweepstakes solely by scanning the QR Code.

**IMPORTANT FOR ENTRANTS USING A MOBILE DEVICE TO PARTICIPATE IN THE Sweepstakes:** Message and data rates may apply. Not all mobile telephone providers carry the service necessary to participate in this Sweepstakes and/or obtain a Website link. Entrants should consult their wireless providers' pricing plans.

**Entry Limit:** There is a limit of one (1) entry per person during the entire Sweepstakes Period. If more than one (1) entry is received from the same person and/or e-mail address, only the first entry received may be considered valid.

**4. RANDOM DRAWING:** On or about May 4, 2021, the Administrator will randomly select twenty (20) potential winners from all eligible entries received. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

**5. PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:**

**A. Prizes (20):** Each prize is an "Adventure Pack" which consists of a tent, hammock, cooler backpack and lantern ("Prize"). No more than twenty (20) Prizes will be available in the Sweepstakes. The ARV of each Prize is \$200.

**B. Total ARV:** The total ARV of all Prizes available in the Sweepstakes is \$4,000.

**C. Odds of Winning:** The odds of winning a Prize depend on the number of eligible Sweepstakes entries received during the Sweepstakes Period.

Prize details and availability are subject to change and Prize provider's rules and restrictions, and in the event that Sponsor is unable to provide an identified school a Prize, the Sponsor may elect to provide the school with the approximate value of such item in cash or award an alternate prize of comparable or greater value. The Sweepstakes Entities shall not be held responsible for any delays in awarding a Prize for any reason. If, after a good-faith attempt, Sponsor is unable to award or deliver a Prize, the Prize may not be re-awarded. Prizes, if legitimately claimed, will be awarded. Unclaimed Prizes will be forfeited.

**6. HOW TO CLAIM A PRIZE:** The potential winners are subject to verification of eligibility and compliance with these Official Rules. After the random drawing, Administrator will notify the potential winners via e-mail at the e-mail address provided at the time of registration. Failure to provide all

required information within the stated time period may result in forfeiture of a winner's right to claim his/her Prize, and may result in the Prize being awarded to an alternate winner, if time permits. If a potential winner is disqualified, found to be ineligible or not in compliance with these Official Rules, declines to accept a Prize, the respective Prize may be forfeited. If a Prize is forfeited, the Prize may be awarded to an alternate winner, selected in a random drawing from among all remaining eligible entries, as determined by Sponsor in its sole discretion. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JAMS IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("JAMS RULES"). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MICHIGAN. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN OAKLAND COUNTY, MICHIGAN. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR SWEEPSTAKES ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION. ANY DEMAND FOR ARBITRATION MUST BE FILED WITHIN ONE (1) YEAR FROM THE END OF THE SWEEPSTAKES PERIOD, OR THE CAUSE OF ACTION SHALL BE FOREVER BARRED.**
